The Tamil Nadu Medical Council hereby call for applications from Universities, Recognized Medical Colleges, Professional Associations, IMA (National, State and Branches), National Academy of Medical Sciences, Specialists and Super Specialist Associations (National, State or Regional level), Postgraduate Medical Institutions, Central and State Govt. Hospitals, State Level Medical Organizations of Repute, Private Medical Institutions with Multispeciality Departments, Private Medical Institutions registered as Trust etc., for Accreditation with the Council to hold approved Continuing Medical Education (CME) programmes with credit hours for the participants for the period 2018-2023.

**GUIDELINES FOR ACCREDITATION OF ORGANISATIONS FOR CONDUCTING C.M.E. WITH CREDIT HOURS APPROVED BY TNMC FOR THE PERIOD 2018-2023.**

1. Starting on 21-05-2018 will be completed by 20-07-2018.
2. Accreditations valid for 5 years.
3. All organization already accredited should renew for the same next 5 years.
4. The fees for accreditation will be Rs.10,000/- per organization for a period of 5 years.
5. We will Accept that private Hospitals which Conducting National Board Examination or 50 Beds Hospitals, Will Eligible For applying Cme Programmes.
6. The fees for accreditation Rs.1000/- For IMA Only
8. These accredited organisations can hold any number of C.M.E.s (Based on the guidelines of MCI/TNMC) in the next 5 years.
9. These organizations will be allocated E-mail id by TNMC.
10. For every CME, they should intimate the TNMC of the programme in the prescribed format, 7 Days prior to the CME, through the designated Mail id.
11. The same to send details of attendance as Xerox copy and in prescribed format within 7 days on completion of CME through the designated Mail id.
12. These organizations should pay Rs 50 per participant as import crediting fees or If you want Certificates Pay Rs.100 Per Participant and send as DD to TNMC within 7 days, per participant.
13. TNMC will credit the CME hours within 10 working days on receipt of the details and fees. The same will be conveyed to the individual by a SMS from council and updated against their names in TNMC website.
14. Accredited organizations must issue attendance sheet to all participants.
15. Council can do surprise inspection of the CME's or verify any documents and records related to the CME by its observers.
16. All accredited organization will be issued an authorization certificate by the Council for the purpose.
